THE SHELTER HELPED THE COMMUNITY THROUGH THE TNR (TRAP-NEUTER-RETURN) PROGRAM BY PROVIDING HUMANE TRAPS TO ENCOURAGE PEOPLE TO ALTER STRAYS, AND BY MAKING TNR CLASSES AVAILABLE TO THE COMMUNITY.
